GCT Roadmap Release planning

Today

- Three major releases per year
 - New functionality
 - New modules
- Service Packs
 - In general one to two service packs per major release
 - Minor changes
 - Bug fixes
- Going forward goal is to be more agile, to add customer value quicker
 - Three month roadmap and release planning
 - Full Monthly releases
 - As soon as something is ready it should go out in next monthly release
- New release naming from 5.35 to 20.3 year.month

Current Release

- 5.35 November 2019
 - Removal of 350 NOK Limit 1st January
 - Global trend on addressing e-Commerce growth on domestic markets
 - VAT On Small Consignment VOSC, VAT payed by supplier outside TVINN (does not apply to food, alcohol or tobacco)
 - If not Registered or food, alcohol or tobacco, VAT payable as part of normal clearance process
 - Barcode on Import SAD and Pre-Arrival Notification
 - New Country groups, including for UK
 - Type A improvements
 - Adjust mapping NO Godsregistering to Declaration
 - Copy multiple containers from grid to all Items
 - Norway godsregistrering address search
 - Bulk Update of Stock Records in Bonded Warehouse
 - TURN Tariff Improvements





Future Releases

- 20.3 March 2020
 - Ekpressfortolling
 - New validation on FO (temporary declaration) vs EN (final declaration)
 - Change in the customs id serie (Ny oppbygning av løpenummer).
 - Today, YYYYNNNNNN e.g. 2019123456
 - From 01.01.2020 will change to YYNNNNNNN
 - January 01, 2020 starts 20 20000001
 - January 01, 2021 starts 21 00000000
 - New declaration type (SF Samlefortolling).
 - New payment code F to be invoiced by Tax Administration (Sometime after Feb 2020)
- Medium Long Term
 - Tariff and other data sources moving to APIs
 - NCTS Phase 5 2023
 - New Data Model EUCDM
 - XML

Summary

• Ability to pre-lodge Import Declarations and submit Manifest data to Norwegian Customs to allow advance Risk Assessment and quick border crossing.

Roadmap: Planned in GCT Release 20.3 March 2020

- Separate module under customs in GCT
 - New Customs Module and Summary Screen of Manifests
 - Create a new manifest via drag n drop from Import, Export and NCTS declarations
 - Update a manifest by add/remove declarations to a manifest that already exists
 - Full trailer loads only. No consolidated loads

Workflow

- Drag N Drop one or more Imports, Transit or Exports to create a new Manifest or update an existing Manifest (add/delete declarations)
- Manually Create a Manifest and capture data, including External Documents
- Send Data to Customs
- Update manifest
- Get Manifest data from Customs to obtain Release / Departed status
 - Statuses
 - Rejected
 - Accepted
 - Released
 - Departed
