







# Global Tariffs Are On the Move

#### GLOBAL TARIFFS OVER TIME



- The above chart illustrates the average tariff over time across WTO and non-WTO countries worldwide<sup>1</sup>
- The findings reveal that the average of global MFN rates has fallen by 14%, or by 1.5 percentage points, since 2005
- However, following actions such as U.S. Sections 232 and 301, world average tariffs are anticipated to trend up with an overall rise estimated for 2018

### ► A REGIONAL PERSPECTIVE



- North America and Europe clock in with the lowest average MFN tariff rates worldwide, with Africa levying the highest tariffs
- Europe has seen the greatest decline in tariffs over time with a 2.6% decrease since 2005
- The Asia-Pacific region assesses lower tariffs, which may be due, in part, to the large number of trade agreements in the region

Each tariff change means that businesses must continuously revisit and adjust supply chain strategies over time to stay competitive.




# Trade Agreements Trending Up

### REGIONAL TRADE AGREEMENTS (RTAs)



- The proliferation of total RTAs is clear with current numbers reaching record levels<sup>2</sup>
- As of August 2018, the WTO counts 287 active RTAs under which two or more countries have agreed to formalize trade
- The nature of many recent agreements has changed with new generation multilateral trade agreements growing more common

### A REGIONAL PERSPECTIVE



- At a regional level, trade agreements have substantially risen for all locations since 1999
- The Asia-Pacific region tops the list with the largest number of agreements, with the landmark Comprehensive and Progressive Agreement for Trans-Pacific Partnership (CPTPP) inked in March
- Many newer trade agreements not only touch upon the issue of tariffs, but also set out increasingly complex rules

In an environment of proliferating trade agreements, it is critical to quickly locate and search for applicable RTAs at the HS level.










# Rapidly Changing Trade Policy









# Non-Tariff Measures Are On the Rise

#### NAFTA NON-TARIFF MEASURES OVER TIME



- The above analysis tracks combined NAFTA member Anti-dumping (AD) measures geared toward perceived lower priced goods, and Counterveiling (CV) measures aimed toward goods perceived to be subsidized<sup>3</sup> over time
- After a previous drop, the number of AD measures initiated or in-force by year has risen to near post-recession levels
- Counterveiling measures among NAFTA members have reached an all time high with 121 actions initiated or in-force in 2017

#### TOTAL NON-TARIFF MEASURES PER NAFTA MEMBER



- With 120 total measures underway or in-force, the U.S. leads the way in Counterveiling instances among NAFTA members
- The U.S. also issues the majority of Anti-dumping cases with a total of 378 actions introduced or currently effective
- Base metals and articles of metal comprise the majority of total Anti-dumping and Counterveiling actions for all three countries due to the importance of these products to manufacturing

While much focus falls on tariffs, a rising number of complex non-tariff measures remain a substantial hurdle for supply chain professionals.

# Conclusion

As shown in the example to the right, a tariff change on even a few HS codes can have a substantial impact on supply chain trends. Magnify this change across a growing number of policy shifts, add-in a rising number of trade agreements, non-tariff measures, and the complexity rises.

Market leaders need knowledge and automated methods to pinpoint change. They require current duty rates, accurate bilateral or multilateral trade agreements data down to the HS level, methods to identify which products have been targeted with what anti-dumping or counterveiling measure, and more. Best-in-class businesses also need methods to track import and export trends as supply chains adjust in parallel to trade policy fluctuations.

In addition, many companies need to stream fully vetted trade data into existing Enterprise Resource Planning (ERP) platforms and other systems to further analyze potential and highlight risk.
