HAVING SEEN File EX-2023-88832016- -APN-REYS#ENACOM of the registry of the NATIONAL COMMUNICATIONS ENTITY, and

CONSIDERING:

That by Decree No. 267 dated December 29, 2015, the NATIONAL COMMUNICATIONS ENTITY, an autonomous and decentralized body, was created as the Enforcement Authority of laws No. 27,078 and No. 26,522, its amending and regulatory standards, assuming the functions and powers of the former FEDERAL AUTHORITY OF INFORMATION AND COMMUNICATIONS TECHNOLOGIES and of the former FEDERAL AUTHORITY OF AUDIOVISUAL COMMUNICATION SERVICES.

That by Resolution No. 729 dated December 24, 1980 of the registry of the former SECRETARIAT OF COMMUNICATIONS and amendments, the creation of the Registry of Telecommunications Activities and Materials (RAMATEL) was ratified and its Regulations were approved.

That by Resolution No. 784 dated November 27, 1987 of the registry of the former SECRETARIAT OF COMMUNICATIONS, the coding of telecommunications equipment that to date does not have technical standards was included in the Registry of Telecommunications Activities and Materials (RAMATEL).

That in the file mentioned in the Seen hereof, the appellant has requested the registration in the Registry of Telecommunications Activities and Materials (RAMATEL) of a telecommunications equipment and has completed all the requirements established in the current regulations.

That the Report linked to the request made by the indicated file indicates that the presentation complies with the provisions of the resolution mentioned in the third recital hereof, considering it appropriate to grant the requested registration.

That this measure is issued in use of the powers conferred by RESOL-2017-1630-APN-ENACOM#MCO, dated March 9, 2017.

ARTICLE 1.- Registration is granted in accordance with the provisions of Resolution No. 784 dated November 27, 1987 of the registry of the former SECRETARIAT OF COMMUNICATIONS, to the team whose characteristics are indicated below:

ARTICLE 2.- It is established that each unit, whose registration is granted by this Provision, must be identified in accordance with the minimum mandatory guidelines for the marking of equipment, established in the specific regulations in force and those that may eventually be issued.

ARTICLE 3.- It is established that the registration granted by Article 1 is valid until there is a definitive technical standard issued by the competent body, with a maximum period of THREE (3) years counted from the date of this document. Provision, moment from which it will automatically expire if there is not a request similar to the one dealt with in these proceedings, which must be filed within THIRTY (30) calendar days prior to expiration.
