Challenge: Preventing Fraud and Speeding Onboarding

With cargo theft on the rise, Royal Transport required a more robust way to quickly ensure every carrier's legitimacy and to guard against fraud and identity theft of carrier MC numbers. Brokers were bogged down in administrative tasks—spending up to 20-30 minutes per carrier on setup by emailing, faxing, and verifying information manually—eroding the time available for revenue-focused activities. In addition, with bad actors growing more sophisticated, frequent red flags like spoofed addresses, unverified phone numbers, or mismatched FMCSA data threatened to slip past the team, risking major financial losses.

Solution: Automated Vetting and Real-Time Alerts with Descartes MyCarrierPortal

To safeguard its premium loads and improve day-to-day efficiency, Royal Transport implemented Descartes MyCarrierPortal as its core onboarding and compliance platform. By establishing preset parameters and leveraging real-time updates, the company quickly identified unfit carriers and significantly cut down on repetitive tasks.

With MCP's configurable rules that instantly flag carriers lacking proper insurance, authority, or contact details, the company gets immediate go/no-go feedback, which saves brokers from unwittingly onboarding risky partners. "If Descartes MyCarrierPortal says 'no,' 98% of the time we don't even invite them to onboard," said Kaleb Groce, Director of Operations at Royal Transport. In addition, if a carrier triggers any red flags, managers must review and approve before the load is tendered.

The solution also provides real-time notifications of carrier status changes, triggering email alerts if a carrier's rating, authority, or insurance data changes. This gives the company a chance to react before tendering high-dollar freight. For extra-sensitive shipments, brokers can also require drivers to submit VIN-validated truck photos from the pickup location, verifying that the vehicle matches the carrier's records, providing an additional layer of security.

By leveraging Descartes MyCarrierPortal, Royal Transport ensures that every carrier on its roster is verified and trustworthy, letting the team confidently cover more loads and safeguard shipments. "The system saves our brokers hours of wasted time while protecting us from the worst-case scenarios," emphasized Groce. "It's been a game-changer for high-value freight security."
